**Narrative**

ON 10/30/21 AT THE INTERSECTION OF PLEASANT ST AND MAIN ST IN MAQUOKETA IOWA, UNIT 2 STOPPED AND PROCEEDED THROUGH THE INTERSECTION EAST BOUND. UNIT 1 THEN APPROACHED THE INTERSECTION, STOPPED BUT FAILED TO ENTER THE INTERSECTION UNTIL IT WAS CLEAR STRIKING UNIT 2 BEHIND THE PASSENGER SIDE REAR DOOR. UNIT 2 HAD THE RIGHT OF WAY. BOTH PARTIES HAD MINOR DAMAGE AND NO INJURIES REPORTED.
